Arranged chronologically by date.

Minutes, 1899-1901, Democratic State Conventions. In addition to routine business procedures, these minutes document the Democratic party of Alabama's stand on many topics, including the constitutional convention, the nomination of candidates, white supremacy, efforts to prevent blacks from voting, and resentment over the belief that blacks were being educated and otherwise supported at the expense of white Alabamians. Minutes, 1899-1904, Democratic State Executive Committee meetings. In addition to routine business procedures, these minutes document discussions on many topics, including the constitutional convention, vacancies, nomination of candidates, primary elections, contested elections and county executive committees. Arranged chronologically by date.

Minutes, 1904-1908, Democratic State Executive Committee meetings. In addition to routine business procedures, these minutes document discussions on many topics, including primary elections, election contests, the 1901 constitution, method for selection of candidates (through primary elections or by convention), county executive committee matters, the Democratic National Convention, nomination of candidates, and discussion of party policies and law. Minutes, 1904-1906, Democratic State Conventions, documenting the election of delegates to the Democratic National Convention and nomination of electors. Arranged chronologically by date.

In addition to routine business procedures, these minutes document many topics, including candidate qualification requirements, procedures for filling committee vacancies, voter registration and primary elections. The bulk of this series contains primary campaign literature related to over twenty offices and issues, 1910. Records concerning the Alabama Democratic Convention and the Alabama Democratic party platform, 1910. Resolution, 1910, setting the date for the democratic primary election. Arranged alphabetically by folder title.

SERIES B: MINUTES**5.28-29**

Minutes, 16 May 1910, Democratic State Executive Committee meeting. In addition to routine business procedures, these minutes document discussions on many topics, including candidate qualification requirements, qualification fees, election contests, and tabulation of election returns. Minutes, 17 May 1910, Democratic State Convention, documenting the election of a SDEC chairman, and the adoption of a party platform which included a stand on temperance, opposition to a high tariff, nomination of supreme court justices by convention, immigration of "desirable white people" to Alabama, improved mining laws, public education, financial support of Confederate veterans and widows, and the creation of a State Highway Commission. Arranged chronologically by date.

Minutes, 1910-1914, State Democratic Executive Committee meetings. In addition to routine business procedures, these minutes document discussions on topics such as resignations, vacancies, candidate qualification fees, selection of delegates to the Democratic National Convention, election contests, primary system vs. convention system, adoption of party rules, tabulation of primary returns, selection of electors, eligibility requirements for voters and committeemen, and the preservation of white dominated politics. Minutes, 17 April 1912, Democratic State Convention. These minutes document routine party business, selection of convention officers, nomination of candidates for state offices, and adoption of a party platform concerning home rule, tariffs, prohibitive taxation, the lavish appropriations of the Republican congress, an amendment to the Federal Constitution providing for Senatorial elections by direct votes, the merchant marine, construction and maintenance of post-roads, the Monroe Doctrine, federal income tax, and the revision and codification of banking laws. Arranged chronologically by date.

Correspondence, 1917-1918, primarily between SDEC secretary Walter Sessions and numerous candidates and committeemen, concerning topics such as declarations of candidacy, resignations, prohibition, the Anti-Amendment campaign, the feasibility of calling a committee meeting, and personal business matters. By-laws and rules of the State Democratic Executive Committee, 1915. Election records include sample ballots, 1918. Financial records, 1918, including bills for furniture and ice service for the Anti-Amendment headquarters. Printed materials, 1915-1918, concerning the registration of electors, and a voting guide. Resolution, 1918, regarding the "Federal Amendment and Its Threat to Southern Civilization." Arranged alphabetically by folder title.

SERIES B: MINUTES**7.1-3**

Minutes, 1914-1918, State Democratic Executive Committee meetings. In addition to routine business procedures, these minutes document topics such as vacancies, the Democratic National Convention in St. Louis, nomination of presidential and vice-presidential candidates, dropping "Conservative" from party name, tabulation of primary returns and school funding. Arranged chronologically by date.

SUB-GROUP XV: J. K. DIXON ADMINISTRATION, 1918**SERIES A: ADMINISTRATIVE FILES****7.4-8.9, Oversize #31.1**

Correspondence, 1918, primarily to George Estes, secretary of the SDEC, from candidates. In addition to routine business matters, topics discussed include declarations of candidacy, questions concerning the legality of requesting assessment fees from candidates, requests from candidates to return or hold assessment payments until legality of assessments determined, notification of candidates that they have been nominated, the settling of debts, and routine business correspondence. Election records, 1918, including Certificates of Results from primary elections as certified by county chairmen, and blank official primary election ballots. Records of election contests, 1918, in Clarke County -- Coates vs. Cox, and Russell County -- Ragland v. Daniel. Financial records, 1918, including receipts for services rendered, office supplies, communications, and expenses incurred by committee members while attending meetings. Lists of committee members and candidates, 1918. Resolutions, 1918, concerning a special primary election, pledging unanimous support of the delegates to Democratic National Convention for Cox and Roosevelt, instructing telegrams to be sent to congratulate and offer support to vice presidential and presidential candidates, and placing the proposed prohibition amendment before the electors for ratification. Arranged alphabetically by folder title.

SERIES B: MINUTES**8.10-16**

Minutes, 1918, Democratic State Executive Committee meetings. In addition to routine business procedures, these minutes document topics such as the vacancies, resignations, the calling of primary elections, tabulation of primary election returns, publication of election results, financial matters, election contests, the prohibition amendment, proposed federal amendments, and World War I. Arranged chronologically by date.

Correspondence, 1918-1919, concerning finances, political strategies, and requests for information about county committees. Financial records, 1919, including bills and receipts for office supplies, communication expenses and advertising. Arranged alphabetically by folder title.

Correspondence, 1918-1922, between committee members, committee officers, county officers, national committee members, candidates, and others. In addition to routine business matters, topics discussed include vacancies, primary elections, qualification of candidates, financial matters, prohibition, mail ballots, the Democratic National Convention in San Francisco, election contests, the barring of bolters from primary elections, and women's suffrage. Election records, 1919-1921, including certificates of primary and special election results from counties, and various official and sample ballots. Records of contested elections, 1920, including testimony, findings, exhibits and press clippings, in Tallapoosa County -- Plant v. Tucker and Henry County -- Whiddon v. Whitehead. Financial materials, 1920-1921, including records of assessments paid, candidates' expense accounts, and committee expenditures. Lists of committee members, qualified candidates, and partial lists of registered voters, 1920. Printed materials, 1919-1920, including "Democratic Bulletin," "Smith-Towner Bill," and "Alabama Primary Election Law." Resolutions, 1919-1922, concerning primary elections, qualification of voters, the Federal Suffrage Amendment, barring those who had bolted from prior elections, post-War economics and the National Convention in San Francisco. Arranged alphabetically by folder title.

Minutes, 1919-1922, State Democratic Executive Committee meetings. In addition to routine business procedures, these minutes document topics such as vacancies, qualifications of candidates, primary elections, canvassing of election returns, election contests, candidate assessments, white supremacy, women's suffrage, the Democratic National Convention in San Francisco, prohibition, tariffs, incorporation of women into the committee, Alabama State Bar Association, coordination of the Democratic committees at county, state and national levels, and the selection process for the electors, candidates, and national committee members from Alabama. Arranged chronologically by date.

SUBGROUP XVIII: JAMES H. WEBB ADMINISTRATION, 1922-1923**SERIES A: ADMINISTRATIVE FILES****12.1-14.10**

Correspondence, 1921-1922, between committee members, committee officers, county officers, national committee members, candidates, county officials, and others. In addition to routine business matters, topics discussed include primary elections, resignations, vacancies, declarations and qualifications of candidates, campaigns, nomination of committeewomen, Henry Ford and the Muscle Shoals project, J. Thomas Heflin, and the Underwood Campaign. Records of contested elections, 1922, in Barbour County -- Grubbs v. Lee, Clarke County -- Garrett v. Cunningham, Coffee County -- Stevens v. Watkins, and Geneva County -- Radford v. Commander, and Rivenbark v. Black and Roach. Financial records, 1922-1923, including check stubs, and receipts and expenditures for office supplies, services rendered, and communications. Lists of qualified candidates, 1922. Arranged alphabetically by folder title.

SERIES B: MINUTES**14.11-28**

Minutes, 1922-1923, State Democratic Executive Committee meetings. In addition to routine business procedures, these minutes document topics such as resignations, vacancies, voter qualifications, candidate

qualifications, resolutions, election contests, speaking engagements, campaign funding, selection of women for committees, coordination of Democratic committees at county, state and national levels, "naivete" of newly enfranchised women, Henry Ford and the Muscle Shoals franchise, exclusion of blacks and republicans from voting in democratic primaries, the Port of Mobile, method for selection of judges, revision of primary election laws and transition to new SDEC administration. Minutes, 1922, Democratic State Convention. These minutes record several speeches by Committee and Convention officials, politicians and candidates. Topics presented include the political situation, campaign strategy, patriotism, political issues, legislation, the Woodrow Wilson Administration, the Alabama Bar Association, method for selecting judges, and the desire for "absolute and eternal rule of the white race." The party platform was also presented, including issues such as prohibition, decentralization of state government, education reform, and reductions in taxation, government expenses, and extraneous state employees. Arranged chronologically by date.

Correspondence, 1923-1926, between committee members, committee officers, county committee officers, national committee members, candidates, county officials, and others. In addition to routine business matters, topics discussed include primary and special elections, resignations, vacancies, declarations and qualifications of candidates, campaign matters, sub-committee work, legislation, financial matters, committee rules, election results, the National Negro Democratic League, the Ku Klux Klan, the LaFollett/Davis race, the Musgrove/Underwood race, and female electors in Montgomery County. Records pertaining to candidates, 1923-1926, including rules and qualifications for voters and candidates, declarations of candidacy, certified lists of democratic candidates for local, state and national offices, and a certified list of Republican candidates. Records of contested elections, 1924-1926, in Chambers County -- Sims vs. Jarrell, Coffee County -- Eagerton vs. Kyser, Coffee County -- Marley vs. Brunson, Lee County -- Cobb vs. Betts, Randolph County -- Walton vs. Vann, and Talladega County -- McLane vs. Coker. Financial materials, 1923-1924, including check stubs, bills, and receipts. Printed materials, 1924-1925, including *Third Party Vote in the Presidential Election of 1924*, an issue of *Congressional Record*, "Federal Financing, 1913-1915: Remarks of Hon. Cordell Hull of Tennessee in the House of Representatives," and John W. Davis and Charles W. Bryan for president and vice-president postcards and broadsides. Resolutions, 1923-1926, concerning topics such as primary elections, nomination of a Presidential candidate, requirements to qualify as a candidate in a primary election, SDEC rules and regulations. Included with the resolutions are documents recording the vote of each committee member to accept or refuse resolutions. Recapitulation sheets showing the election results from the 1926 statewide primary election. Rules of the committee, 1923, outlining roles and responsibilities of members, sub-committees, methods for calling and conducting meetings, powers of committee, and financial matters. Arranged alphabetically by folder title.

Minutes, 1923-1927, State Democratic Executive Committee meetings. In addition to routine business matters, these minutes document discussions on primary elections, the revision of primary election laws, single vs. double primary elections, candidate assessments, tabulation of election returns, deadlines for candidate qualifications, qualification requirements of electors, candidates, and delegates to Democratic National Convention, committee rules and regulations, county chairwomen and chairmen, deposit of committee records in the Alabama Department of Archives and History, financial assistance for Democratic campaigning in Republican-dominated counties, method for selection of judiciary, Democratic party loyalty, endorsement of Oscar Underwood as candidate for president of U. S., endorsement of Democratic party platform, and condemnation of Republican administration and the LaFollette ticket. Arranged chronologically by date.

Correspondence, 1927-1931, between committee members, committee officers, county committee officers, national committee members, candidates, county officials, and others. In addition to routine business

matters, topics discussed include resignations, vacancies, primary and special elections, declarations and qualifications of candidates, campaign matters, sub-committee work, pending legislation, financial matters, election results, election contests, political rallies, speaking engagements, political appointments, Democratic National Convention, exclusion of blacks from primaries, immigration, and the Alabama Federation of Women's Clubs. A large percentage of the correspondence relates to the schism within the Democratic party as a result of the 1928 election in which many Democrats bolted from the party rather than support Al Smith as the Democratic nominee for President. Aspects of the split discussed include white supremacy, the barring of the bolters from future elections, Anti-Smith Democrats, the Heflin-Locke ticket, Hoovercrats, Ku Klux Klan, "the Twenty-Seven" [non-bolting members of SDEC], the congressional investigation of Alabama election practices, and "Rome, Rum, Tammany & Raskob." Also of interest are the letters from L. J. Bugg and others detailing the political situation in many counties throughout the state. Records of election contests, 1930, in the 34th Senatorial District -- Darden vs. Smith, Henry County -- the Glover contest, Jefferson County -- Wilkinson vs. Henry, and the contest for U. S. Senator -- Heflin vs. Bankhead. Election records including sample ballots and election returns from general and presidential elections, 1928, filed by county, some detailing vote tallies by beat and box number. Financial materials, 1927-1931, including candidate expenditures, campaign contributions, disbursements, budgets, and duplicate deposit tickets. Lists of candidates, nominees, county election officers, SDEC members, county committee members, local officials, and qualified voters and lists of various committee members at each level with notations as to whether they are Democrats or Hoovercrats, 1926-1931. Also in this series are lists of SDEC members beginning with the 1906 administration and ending with the 1935 administration, with exception of the 1910 administration, for which no membership list was included. Printed materials, 1928-1931, including *Jefferson: The Father of Democracy*, *Porto Rico Delegates to the Democratic National Convention*, a speech on state's rights, an address of Hon. J. Thomas Heflin, Al Smith and anti-Al Smith broadsides, poetry, and newspaper clippings. Resolutions, 1927-1931, calling primary elections, concerning the party platform, supporting members and nominees, and calling a State Democratic Convention. Arranged alphabetically by folder title.

Minutes, 1927-1930, State Democratic Executive Committee meetings. In addition to routine business matters, these minutes document discussions on primary elections, candidate qualifications, selection of electors and alternate delegates, vacancies caused by death, resignation or expulsion, campaign funding, political situations around the state, barring bolters from involvement in the committee, election contests, Democratic National Convention delegates, national committeemen and committeewomen, Ku Klux Klan, and the rules of the SDEC. Several of the minutes are in shorthand. Arranged chronologically by date.

In addition to routine business matters, topics discussed include resignations, vacancies, declarations and qualifications of candidates, primary and special elections, campaign matters, sub-committee work, the political status of various counties, pending legislation, financial matters, election results, election contests, speaking engagements, the exclusion of blacks from primaries, Democratic National Convention, the Victory Drive, various Democratic organizations, the loyalties of Democrats, the barring of "bolters," and the Roosevelt/Garner campaign. County files, 1930-1934, provide information on voting statistics and predictions, listings of "reliable" Democrats, and general notations regarding the loyalty of various candidates and committee members, and the political status of the county. Candidate files, 1931-1934, containing declarations of candidacy, correspondence, and documentation of campaign expenditures. Records of contested elections, 1932-1934, in Barbour County -- Miller vs. Alexander, Cherokee County -- Webb vs. Tracy, Houston County -- Wells vs. Pettus, Jackson County -- McAnelly vs. Starkey, Jefferson County -- Dickson vs. Whetstone and Griffith vs. Jarman, Mobile County -- McFadyen vs. Holcomb, and Shelby County -- Bird vs. Naish. Election records, 1932-1935, containing the certification of the election results in each county and vote tallies. Financial materials, 1928-1935, including bills, receipts, and duplicate deposit slips. Lists of candidates, committee members and voting statistics, 1928-1933. Printed materials, 1931-1934,

including addresses by various national committee members, an issue of the *Congressional Record*, press clippings regarding various Democratic committee matters, and several items concerning the U. S. Constitution. Resolutions, 1927-1934, concerning such topics as primary elections, candidate requirements, qualifications for voters, and the Alabama State League of Young Democrats. Arranged alphabetically by folder title.

Also among the correspondence are mail ballots concerning several of the above issues. Candidate files, 1936-1938, include qualification papers, correspondence and candidate expense accounts. County files, 1935-1938, document campaign funding, requests for financial assistance, and the filling of local vacancies. Records of election contests, 1936-1938, in Coosa County -- Smith vs. Neighbors, Houston County -- Rogers vs. Watford, and Washington County -- Loper vs. Johnston. Election records, 1935-1938, include certification of Democratic and Republican candidates to the secretary of state, election returns, and certified election results. Most of the election records are filed by county. Financial records, 1935-1938, include purchase requisitions, receipts and unpaid bills. Lists of qualified candidates, state and county committee members, and state and county officers, 1934-1938. Printed materials, 1936-1937, include an address of National Committee chairman James A.
